TO ALL EMPLOYERS OF CEMENT MASONS' UNION LOCAL 502 - PLASTERERS' AREA 5

This will officially serve to inform you that on June 1, 2022 a \$2.47 increase will be effective in accordance with our **Five-Year Contract Agreement**. At a Special Meeting of the Membership on May 14, 2022, the Membership voted to allocate \$2.25 in the category of **WAGES** and \$.47 in the category of **FRINGES**.

In the category of **FRINGES**, the Membership voted to allocate an additional \$.14 to the **PENSION**, \$.25 to the **HEALTH & WELFARE** and \$.08 to the **RETIREE WELFARE FUND**. WORKING DUES have been reduced to 4.0% of the total package or \$3.40 per WORK hour. The rates effective June 1, 2022 to May 31, 2023 are as follows:

***NOTE:** Working dues will now be deducted at \$3.40 per WORK hour with no adjustment for OVER TIME or DOUBLE TIME.

****NOTE:** The O&P Fund is a newly established Organizational & Promotion Fund which is a member payroll deduction, not an Employer contribution. \$0.25 per WORK hour with no adjustment for OVER TIME or DOUBLE TIME.

*****NOTE:** The APPRENTICE FUND contribution has reduced to \$1.00 per WORK hour to establish the Organizational & Promotion Fund.

APPRENTICE RATES ARE AS FOLLOWS:

Based on the following percentages of the Journeyman Wage.

(1)	1 st 6 months	50%	\$23.88 per hour
	6 months to 1 year	55%	\$26.26 per hour
(2)	1 year to 1.5 years	60%	\$28.65 per hour
	1.5 years to 2 years	65%	\$31.04 per hour
(3)	2 years to 2.5 years	70%	\$33.43 per hour
	2.5 years to 3 years	75%	\$35.81 per hour
(4)	3 years to 3.5 years	80%	\$38.20 per hour
	3.5 years to 4 years	85%	\$40.59 per hour

Dues deductions for Apprentice Plasterers shall be \$3.00 per hour.

We urge all Employers to bring an Apprentice into the Union through your Company and provide equal opportunity to qualified women applicants. You can also call the Union for a list of applicants.


